### Chairman's Report

The Crawford Art Gallery continued to realise its ambitions in 2023, firmly positioning itself within the family of National Cultural Institutions.

The Gallery delivered over 22 projects and exhibitions, and these embraced broad and relevant themes such as body, identity and loss. We nurtured new and existing partnerships with artists and communities, encouraging and enabling new audiences to visit and spend time in the Gallery.

Our Capital Project, a once-in-a-generation transformation of our buildings, continued apace. We secured planning permission for the redevelopment, and we concluded the extensive and detailed design workshop phases. This major project, which is led by Grafton Architects, will underpin the future of the Gallery. It will contribute also, we believe, to the growth and development of Cork city and the surrounding regions.

The Gallery continued to add to its collection in 2023. This included our first acquisition of a Harry Clarke work in 99 years, the extraordinary *The Colloquy of Monos and Una*, a colour plate illustration for a 1923 edition of Edgar Allan Poe's *Tale of Mystery and Imagination*. This acquisition from auction was supported by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media.

The Gallery embraced major national initiatives for integration of the Irish language and for the night time economy, both of which contribute to the growth of our audience reach.

We are grateful to our many collaborators, including the OPW, Failte Ireland, Munster Technology University, MTU Crawford College of Art and Design, MTU Cork School of Music, Irish Museum of Modern Art, ETB Cork, Port Of Cork, Cork Chamber of Commerce, Cork Business Association, The Irish Examiner, RTE and Cork City Council. We also express our thanks to the other National Cultural Institutions and the galleries and collections, both private and public, from which we loan and to which we lend.

As Chair, I express my sincere appreciation to the Friends of Crawford Art Gallery and our Founder Friends for their loyalty, support and advocacy. I want to thank our parent Department (Tourism, Culture, Arts, Gaeltacht, Sport and Media), Minister Catherine Martin and her officials for their deep and enduring commitment to the Crawford Art Gallery, which manifests itself so clearly in their ongoing support.

I want to thank the Director and staff of the Gallery for their dedication and hard work, for their careful management of the Gallery, and for their ambitious and skilful pursuit of our vision for its future. And I thank my fellow Board members and Subcommittee members, who give their time, expertise and commitment so generously to ensure that the Gallery can thrive and grow.

### Director's Report

2023 was a dynamic year in the Gallery with visitor numbers back to pre-pandemic levels. Ireland's National Cultural Institutions continue to thrive and engage with their diverse audiences in meaningful ways.

Crawford Art Gallery through its collaborations with its national and local colleagues continue to imagine opportunities for our publics to engage with the collection, our artists, our buildings and our programmes.

Our main strategic priority continued to be the Master Development Plan being led by Grafton Architect as part of the Government of Ireland's Capital programme. In partnership with the OPW, we participated fully in the detail design planning workshops to ensure we contribute to the specification's for future art storage, Learn and Explore spaces, additional galleries as well as more hospitable and welcoming environments for our visitors and staff. The project is progressing smoothly through the phases of the public Spending code and will necessitate a closure of the Gallery in late 2024 for the capital works to commence on site.

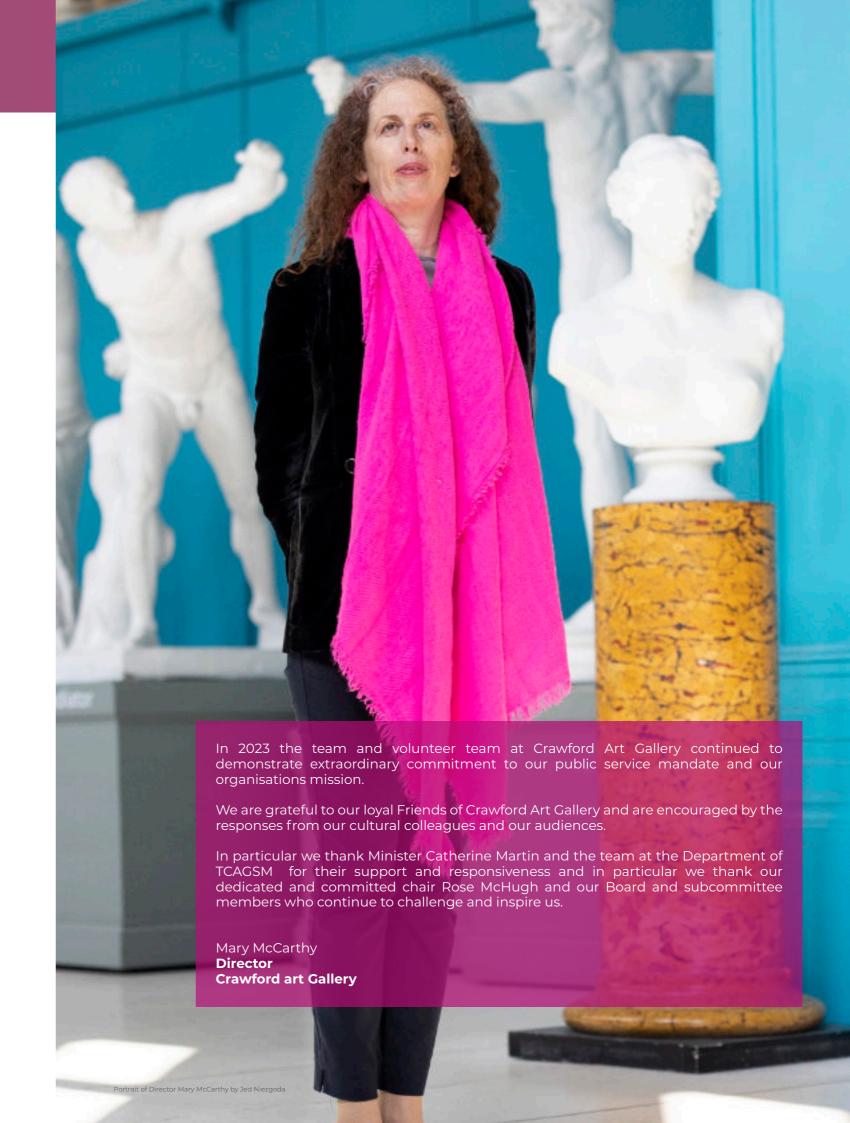
In parallel with the capital development planning, as a team, we continued to enhance and expand the Crawford's outstanding Collection amassed over centuries. We acquired 77 new artworks via acquisition and donation.

This process of acquisition is a thorough one where we acquire significant works by artists that will ensure those works are held In a collection where they can be conserved, exhibited and available to our publics, curators and institutions into the future. The new additions breathe life into the collection creating new conversations across centuries.



2023 saw significant acquisitions of works via auction, Sean Keating 'The Window' and Harry Clarke 'The Colloquy of Monos and Una' both exceptional works that add to our holdings of those artists. We are very grateful to the many donors of works and all those that help us acquire such significant works, in particular Minister Catherine Martin and the department of TCAGSM. Several significant Collection loans were initiated in 2023 to the RHA, IMMA, Limerick City Gallery amongst others.

Our exhibitions and Learn and Explore Programmes continued to probe contemporary issues and unpack narratives through visual art works and processes. We continue to experiment with the various spaces in the Gallery and to expand our audiences sense of our history.



Master Development Plan: March 2023, Planning permission was granted for the ambitious redevelopment of Crawford Art Gallery. The project, which is being funded by the Department of Tourism, Culture, Arts, Gaeltacht, Sports & Media has been designed by an interdisciplinary design team, led by award-winning Grafton Architects, and is being delivered by the Office of Public Works and Crawford Art Gallery.

The project will expand and modernise Crawford in line with international museum standards, providing new exhibition spaces and a Learn and Explore facility to engage new audiences, as well as a new public gallery providing panoramic views of Cork city. The redevelopment will also address long-standing challenges with the fabric of the historic building, providing fit-for-purpose storage spaces for the National Collection, and will significantly enhance the sustainability of the building.

The redevelopment of Crawford Art Gallery is a flagship project in the programme of investments under the National Development Plan, The project is progressing smoothly through the phases of the public Spending code and will necessitate a closure of the Gallery in late 2024 for the capital works to commence on site.

These capital works are essential to ensure Crawford Art Gallery can meet local, national and international visitors' diverse needs in the future and ensure the best possible experience for audiences and communities. The project will ensure this unique building of great heritage interest will be restored and enhanced for future generations.

**Sustainability Operations** and Environmental sustainability is a prime consideration across Crawford Art Gallery's operations, emphasis on achieving sustainable Environmental goals is a priority for the MDP.

2023 saw the formation of the Gallery's dedicated Green Team, and the adoption of the Climate Action Roadmap 2022, which was approved by the Board in November 2023

All public bodies in Ireland have a responsibility, under the Public Sector Equality and Human Rights Duty, to promote equality, prevent discrimination and protect the human rights of their employees, customers, service users, and everyone affected by their policies and plans.

Crawford Art Gallery continues to work in this area by:

- Improving Web Accessibility across a number of the Gallery's public facing platforms and social media activity
- Improving Diversity in Recruitment
- EDI will be a key consideration in the planning and consultation phase for the Gallery's next Strategic Plan (2024–2027).



#### DIVERSITY AND INCLUSION AT CRAWFORD ART GALLERY

#### **Crawford Supported Studio**

Crawford Supported Studio works to provide a network of support allowing artists to test, stretch, sometimes fail, achieve exciting artwork in a safe environment.

Crawford Supported Studios (CSS) exists through partnership with Cork City Council, MTU Crawford College of Art & Design, Crawford Art Gallery and Cope Foundation. It is anchored by this network.

In 2023 Crawford Art Gallery were delighted to share the news that a dedicated webspace for Crawford Supported Studio is live; it showcases artwork, a selection of films, with a developing information section holding catalogues and articles for delving deeper. The website is an advocacy and awareness tool and a point of professional contact for CSS artists <a href="http://crawfordsupportedstudios.com">http://crawfordsupportedstudios.com</a>

2023 was an exciting year for CSS artists with highlights including: artist's portraits on film released monthly across media channels by Crawford Art Gallery and MTU Crawford Art College, a profile piece on artist Íde Ní Shúilleabháin on RTE's This is Art in April, a national meet-up of supported studios in September and a mural project with Cork Penny Dinners and artist Ailbhe Barrett and more.

Crawford Art Gallery are championing these artists because the artwork being produced is inspiring, bold, humorous and engaging to a broad audience. Often fearless.

Support in this context 'looks like' accessible studio space, access to materials and equipment, two dedicated studio facilitators, assistance with transport, communications for non-verbal members, access to exhibitions, audiences, peers, and support in terms of professional training and project development.

Crawford Supported Studio works actively to recognise and meet difference, asserting that diversity in the arts benefits everyone, creating a richer contemporary practice that is reflective of our communities.

Crawford Supported Studios (CSS) were proud to launch a series of compelling portraits of artists on film co-created with photographer Clare Keogh.

A supported studio is a sustained creative environment that centres disabled artists.

Supported Studios provide technical artistic support, professional networks and audiences beyond health and social care settings.

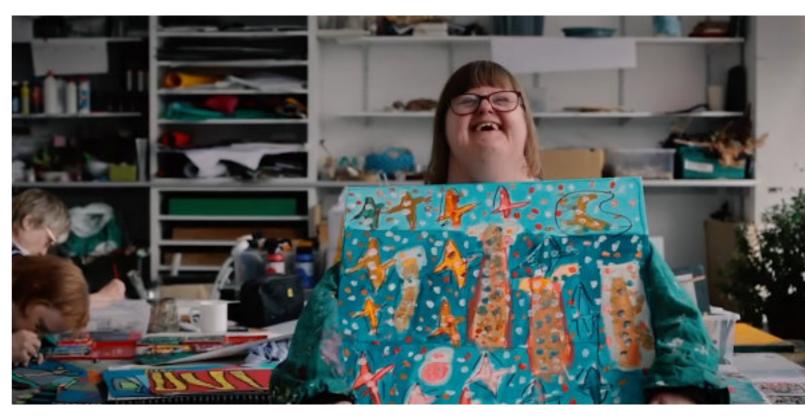
CSS currently creatively supports sixteen artists members in the heart of Cork City.

CSS focuses on ability rather than deficit, insisting that diversity means not just tolerating difference but valuing it.

Moving from the day centre to the city centre; CSS studio members are represented in the national art collection, they have worked alongside third level students and led workshops for young people; they have acted as cultural ambassadors in Cork, Carlow and New York; creating stop-start animation, paintings, prints, street art and site-specific artwork.

A strong collaborative relationship has grown between MTU Crawford Art College and Crawford Art Gallery; with participants meeting on a weekly basis in the Gallery on Tuesdays and at (MTU) Grand Parade on Thursdays to develop their artwork and advance projects together.

In addition to enabling artistic engagement, CSS artists challenge us as cultural institutions to consider fresh approaches to ability, education, gallery programming and cultural diversity.

#### Opportunities for older people at the Crawford Art Gallery include:

- Free, twice-weekly gallery tours (Sundays at 2pm and Thursday evenings) open to all with no booking needed.
- Community and supportive groups can also book a tailored, guided visit with a
  dedicated guide for free and/or low cost if the option of a hands on workshop is
  added to the tour
- CAG has a dedicated, long term programme for adults with memory loss,
   Dementia, Alzheimers called Lonradh.
- Lonradh is named after a stained glass window and is an Irish word meaning to illuminate or radiate. The artist-led programme encompasses sessions in the gallery, visits to Alzeihmer cafés, to St Finbarr's hospital and nursing homes and is centred on artworks from our collection as starting point for conversation with the assistance of multi-sensory prompts and art activities.
- CAG is an active participant in Bealtaine Festival every year
- Work of the Week, weekly series by Conor Tallon and curator Michael Waldron discuss some of the most interesting and unique artworks from the national collection at Crawford Art Gallery on the well-loved radio show hosted by by Elmarie Mawe on 96Fm.
- An independent support organisation, established in May 1989, the Friends´ aim
  is to promote awareness of the Gallery, its collections and exhibitions and to
  foster an interest in all aspects of art, culture and heritage. Their programme is a
  fun, social, creative and educational way to engage with exhibitions and events
  at the Gallery. Members are invited to participate in a program of events
  including talks, exhibition previews, and private tours.

#### RE-INTEGRATION OF PEOPLE SEEKING REFUGE

**Follow your Nose [into drawing]** is the access programme for young co-creators residing in direct provision centres or who have recently moved out of Kinsale road / Ashbourne and Riverside Park Macroom DPs. The programme which was initiated in 2020 consist of online sessions facilitated by the artist Julie Forrester and Fionnuala O'Connell, youth worker at the Cork Migrant Centre. A number of visits and workshops to the gallery are also integral to the programme. In 2023 the participants focussed on their section of the Studio exhibition which were showcase from September 2023.

The free, twice-weekly gallery tours open to all with no booking needed are an introduction to the gallery, Irish art, and more generally to Irish history. In addition we have facilitated a number of tours with hand on workshop with groups of Ukrainians who recently arrived in Ireland, in partnership with the Cork Migrant Centre and Secad Middleton.

#### **LGBTQ+ Tours**

#### Free to all visitors | No booking required

To celebrate Cork Pride Festival, Crawford Art Gallery invited participants to a special LGBTQ+ Tour of its exhibitions. As the gallery continues to diversify its collection, the tour guide featured stories of Dr James Barry, Kate O'Brien, and Fiona Shaw, and artworks by Stephen Doyle and Patrick Hennessy.

Representation in Behind the Scenes 2023

#### REPRESENTATION

A public art collection can be disparate, varied, sometimes oddly specific, but what does it represent and who is represented? A collection may express the times in which it was assembled, the moods, politics, upheavals, events, and aspirations of a people or peoples. The Collection at Crawford Art Gallery began in the context of an art school in the nineteenth century but has seen most of its growth since the dawn of the Irish Free State in the 1920s. It has, perhaps, waxed and waned too according to economic and social change. Perhaps unlike other historic collections, it has significant holdings of artworks by women, with the first being accessioned in the 1890s. Although less strong in terms of racial, ethnic, gender, sexual, and other forms of diversity, progress is being made and the Collection continues to grow to reflect contemporary Irish society, its priorities, and plurality of identities.

Norah Brigid Ní Chuill (1924/25-1993) Game of Cards 1959, oil on canvas

This inter-generational moment of leisure comes at the close of a day, the group's vardo (barrel-top or living wagon) brought to a stop, their horse or pony left to graze. This is a rare example of a Mincéir or Irish Traveller family being depicted in a positive or non-stereotypical light. Instead of a title employing derogatory terminology (often used indiscriminately in the past), the artist is interested in their activity. She presents a shared bond of community and sense of belonging which is contrary to the more dominant depictions of marginalisation, even suspicion.

'I am inspired by the people and places I see in my travels.' Angela Burchill embraces a range of subjects and has developed a unique, vibrant style, as is evident from this series of portraits of her fellow artists. Previously part of the Cúig studio programme and artist-inresidence at Mayfield Arts Centre, she is now a member of Crawford Supported Studio. This is a sustained creative environment for individuals with specific health or social needs, which provides technical artistic support, networks, and audiences outside health and social care settings. Crawford Supported Studio exists through partnership with Cork City Council, MTU Crawford College of Art & Design, Crawford Art Gallery, and Cope Foundation.

#### Stephen Doyle (b.1994) *Dylan Is Ainm Dom...* 2018, oil on board, neon

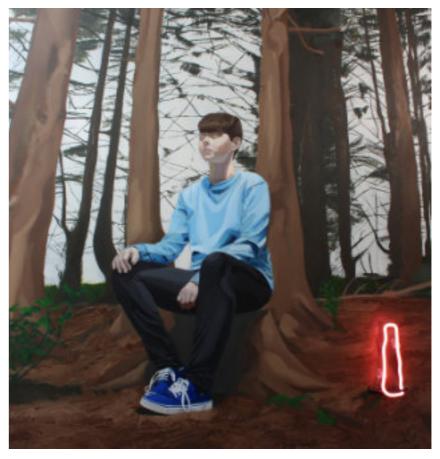
As its Irish language title indicates (My name is Dylan), this portrait of a seventeen-year-old young man explores contemporary concerns with self-identity in Ireland. The setting is near Dylan's home in Lucan, County Dublin. The artist's combination of landscape and oil paint echoes heritage and tradition, yet the use of bold neon implies an 'otherness'. Doyle notes that 'this juxtaposition is not unlike how queer culture has developed outside wider society.' Shortlisted for the Zurich Portrait Prize in 2018, it is thought that this work is the first to enter the National Collection that openly discusses transgender identity. The artist hopes that 'any transgender individual who sees the work will be able to connect with it and know that they belong.'

#### Suzanna Chan (b.1969) The Cabinet of Exotica 1993, oil on canvas

Confronting Orientalism (representations of Asian culture that often embodies colonialist attitudes), this mysterious work reflects the artist's own Irish-Chinese ethnicity. The painting presents an unsettling mix of scenarios, as two hounds chase a lone deer, a seated male cradles a life-size doll, and a richly decorated room hosts the aftermath of dental surgery. Chan's stage-like imagery acknowledges and challenges the performance of stereotypical gender roles, particularly in the context of Asian 'female dollification' under a problematic Westernised gaze.

### Stephen Doyle (b.1994) Meditating Tongqui 2020, oil and mixed media on canvas

Created in the aftermath of a residency in Shanghai, with this work Doyle sought to highlight 'the millions of Tongqui / Tongfu currently living in China.' The artist here uses the term for homosexual people who are married to opposite sex partners, which may be due to 'an obligation to lineage or simply to avoid suspicion of being homosexual or for any number of personal or political reasons. It questions identity, both cultural and sexual. It renders the sitter submerged in an environment void of connection.' Deep in thought, the figure balances and perhaps reflects on what might have been if circumstances were different.

### OFFICIAL LANGUAGES (AMENDMENT) ACT 2021

The Official Languages (Amendment) Act 2021 (the Act) came into law in December 2021. In 2023, in support of fulfilling its obligations under the Act, Crawford Art Gallery completed actions in the following areas:

- Under Section 4(B) of the Act, the Gallery appointed a senior member of staff to oversee the performance and reporting to the Gallery's obligations under the Act.
- Under Section 10(A) of the Act, the Gallery commenced tracking compliance to bilingual advertising using the template provided by An Coimisinéir Teanga.
- Management continues to communicate the details of all Department and An Coimisinéir Teanga Information Seminars on the Act to all staff.
- The Gallery's Marketing and Communications Department has made incremental improvements to Irish language content use on the Gallery's social media channels and advertising.
- The Gallery has hosted free Irish Language events.



Crawford Art Gallery's ambitions and vision continued to grow apace in 2023, firmly positioning itself within the family of National Cultural Institutions. Its team created and delivered energising encounters of over 22 projects and exhibitions that embraced pertinent themes and celebrated the National Collection. New and existing partnerships with artists and communities were nurtured across the year, creating new audiences to linger in the galleries longer.

The first three months of 2023 saw the conclusion of a number of exhibitions which commenced in 2022 including the critically acclaimed exhibition **Corban Walker: As Far As I Can See** which was accompanied by the artist's enriching curation of the Collection. *Other Worlds: Harry Clarke Watercolours* – the fifth annual exhibition of Crawford Art Gallery's collection of the artist's works explored Clarke's capacity for world-building and storytelling. The exhibition was accompanied by a special event in which novelists **Laura McKenna** and **Éibhear Walshe** discussed their approaches to historical fiction. Whilst **Behind the Scenes: Collection at Work** ventured beneath the surface of selected artworks to reveal the process of making, display, conservation, representation and language.

The second week of January marked the much-anticipated annual tradition of a lost coastal sound returning to echo through Cork city centre. *Found Sound (Lost at Sea)* 11.1.11 is an installation by sound artist **Danny McCarthy** from the national collection and was audible intermittently throughout the day and served as a reminder of what was once an imperative soundtrack to daily life.

Collection exhibitions **RADHARC:** Dearcthaí i bPrionta | Perspectives in Print and SITE OF CHANGE: Evolution of a Building punctuated the spring programme in the Gibson Galleries and Long Room respectively.

The Irish word *radharc* suggests a prospect, view, or scene, a range of vision or something seen. Drawn from Crawford Art Gallery's extensive print collection, this exhibition offered a cross-section of printmaking practice over the past century.

**RADHARC** (4 February – 21 May) surveyed topographical perspectives and introspective states contemplating what enters the artist's field of vision and how do they perceive or propose what they envision?

The exhibition featured artists Norman Ackroyd, Katherine Boucher Beug, Naomi Boretz, Georges Braque, Christo, Jan de Fouw, Otto Dix, Micheal Farrell, Gary Farrelly, Anna R. Findlay, Joy Gerrard, Debbie Godsell, Mark Hathaway, David Hockney, Robert Indiana, Fiona Kelly, Paul Larocque, David Lilburn, Aidan Linehan, Frieda Meaney, Joan Miró, Cóilín Murray, Jennifer O'Sullivan, Eduardo Paolozzi, Pablo Picasso, Nigel Rolfe, Georges Rouault, Mabel Allington Royds, Maria Simonds-Gooding, Edward Twohig, and Corban Walker.

**Radharc** was mediated through bilingual (Gaeilge and English) signage and was also accompanied by a guided tour (5 March 2023) presented through the Irish language by **Billy Lingwood**, an artist specialising in printmaking, which offered a unique perspective to visitors.

As Crawford Art Gallery prepares to embark upon a fourth century of development, **Site of Change: Evolution of a Building** (4 March – 12 November) was a timely reflection on the evolution of its site, building, and function from 1724 to the present. Curated by **Tom Spalding** and Michael Waldron, this exhibition explored how the building has changed with the times.

Repurposed from its original role as Custom House, it has operated as a School of Art, Municipal Art Gallery, and National Cultural Institution. At each shift in purpose, it has adapted and grown in response to the needs of the city and its people.

Featured in the exhibition were works by artists Emily Anderson, George Atkinson, Domenico Brucciani, John Butts, Thomas Chambers, Augustin Amant Edouart, Mark Hathaway, Arthur Hill, Charlotte Kennedy, Colin Leahy, Richard Lyster, Danny McCarthy, Canon E. P. Mills, Walter A. Mulligan, Séamus Murphy, Orla O'Byrne, Diarmuid O'Ceallacháin, Mary A. O'Neill, Henry Jones Thaddeus, William Willes, Richard Benjamin Wood alongside the loan of an unique architectural model of a proposed design for Crawford Municipal School of Art by Arthur Hill.

The Power of Us (31 March 2023 – 5 March 2024), an ambitious year-long screening programme, told stories of people who are passionate about what they do. Inspiring and innovative the subjects of these films, possessed deep knowledge of their occupations. At a time when there exists a suspicion of the expert these films acknowledge individuals who come together with their expertise to make ripples and sometimes waves in our society. Films included Clare Keogh: Portraits of the Artists (2023) featuring artists from Crawford Supported Studios; Lisa Fingleton: Voices from the Fields (2022): Michelle Delea: The Sprawling Octopus of an Elevated Highway (2022; Anthony Haughey in collaboration with My Sister's Keeper: This Is What We Call Progress (2021) and Venus Patel: Eggshells (2022).

The summer months were programmed with a specific focus on the human body with *muscle: a question of power, Bodywork* and *Wiggle Room* (all **28 April – 20 August) complementing each other thematically.** 

**muscle:** a question of power was an immersive audio-ambulatory-installation experience, created by **Anna Furse**, for the visitor to Gallery's collection of **Canova Casts**. Designed to guide the spectator into specific proxemics, perspectives and focus on these classic figurative sculptures, **muscle** invited a contemplation of a range of questions about the body, naked and clothed, and its meaning in Western civilisation. Such questions also suggest that the viewing of these art works – formerly both objects of international relations and pedagogic tools – be from a 'lived body' experience; that is, the visitor/viewer, through a text/sound audio guide, will be encouraged to experience the visit not only visually but viscerally and imaginatively.

**Bodywork** featured artists and the collaborative partnership of the **Irish Museum of Modern Art** (IMMA) and **Crawford Art Gallery** in their recent acquisition of new works for the **National Collection**. Curated by Dawn Williams, *Bodywork* explored aspects of art making that interrogate how our bodies perform under internal and external forces and through lived experiences. In doing so, the exhibition offered a space to consider our bodies and how they relate to our understanding of body image and highlighted the crucial relationships between contemporary art practice and the body.

Artists featured: Rachel Ballagh, Elizabeth Cope, Yvonne Condon, Stephen Doyle, Rita Duffy, Debbie Godsell, Eithne Jordan, Dragana Jurišić, Breda Lynch, Brian Maguire, Leanne McDonagh, Eoin McHugh, Nick Miller, Peter Nash, Maïa Nunes, Sandra Johnston, Alice Rekab, Rajinder Singh and Jennifer Trouton.

Whilst **Wiggle Room** in the upper gallery, underlined the need for a space within the gallery for audiences to take some time out to sit, dwell, read, stop and perhaps wiggle. With a range of books that complemented the exhibitions – and comfy seating kindly sponsored by **EZ Living Interiors** – it was a huge success and unlined the need for safe, calm public spaces.

In her major solo exhibition **Rita Duffy:** *Persistent Illusion* (10 June – 30 October) Duffy presented a trilogy of new, largescale works that addressed urgent themes of planetary crisis and political chaos. This triptych for our times, included *Epiphany* (2021) and *Ship of Fools* (2022), had its genesis in the artist's intense series of small, satirical drawings, *The Emperor has No Clothes* (2020), which was acquired by Crawford Art Gallery for the National Collection. The publication *Persistent Illusion* with essays by **Sarah Kelleher** and **Yvonne Scott** was published by Crawford Art Gallery to accompany the exhibition.

The autumn months saw two important exhibitions one highlighting the Gallery's essential **Learn & Explore** programme and its partnerships, the other platforming artists who in their practice investigate a variety of new and age-old concerns with fibres and threads.

Art is a doing thing, and *L&E STUDIO* was centred on making and learning together. Art is often playful and experimental and the Gallery's Learn & Explore programmes support a range of learning and exploratory activities including: children's art classes, children's animation programme, a collaborative art programme with *Cork Migrant Centre*, teen programmes, portfolio preparation, the *Crawford Supported Studio* in partnership with *MTU Crawford College of Art & Design*, Lonradh – a long-term memory-loss and dementia-friendly creative programme, tours and art and well-being workshops.

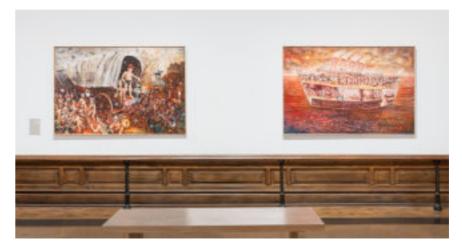

The critically acclaimed Following Threads exhibition (9 September 2023 – 28 January) curated by Anne Boddaert, spotlighted areas of practice we are curious about and interested in. Textile based artworks have been a growing presence in art galleries over the last decade with artists investigating a variety of new and age-old concerns with fibres and threads.

The boundaries of traditional techniques such as weaving and embroidery have been pushed by artists who are interested in embracing the potential of thread in contemporary art. *Following Threads* featured works by Ailbhe Ní Bhriain, Isabel Nolan, Matt Smith, Ciara O'Connor, Cecilia Danell, Mainie Jellett design by Ceodogán Rugs, Dorothy Cross, Michelle Malone, Jennifer Trouton, Anne Kiely and Mary Palmer.

The Gallery's three prodigious **Harry Clarke** stained-glass panels returned to display in **Conserving Harry Clarke**: **Early Stained Glass** (8 **September – 26 November)** following expert conservation by **Philip Crook** (Vitrail Studios). Fitted to custom-made conservation-grade LED frames, visitors will experience these rare early examples of Clarke's work like never before. Their redisplay is accompanied by a specially commissioned short film by **Marcella O'Connor** that documented the conservation process. This conservation project was funded by **The Heritage Council** through the **Heritage Stewardship Fund 2023**.

Artists' Film International 2023 responded to the theme of Diaspora and this year's selection was presented in partnership with the Cork International Film Festival. For its 2023 participation, Crawford Art Gallery invited London based artist Michelle Deignan to contribute the film, Looking for Gary (2018). Michelle Deignan joined with fellow internationally known artist Jasmina Cibic in creating an intimate public conversation about their respective practices and the role of 'soft power' in culture.

**Extended by popular demand,** *Bad Romance* (2 December 2023 – 25 February 2024) was the sixth annual – and largest – exhibition of Crawford Art Gallery's collection of works by **Harry Clarke**. Newly presented in the Long Room, the exhibition featured all 27 works on paper and stained glass, having been joined by new acquisition, *The Colloquy of Monos and Una* (1923). The other 26 works were purchased from the artist in 1924 and range from the macabre to the amorous to the spiritual, delighting – even startling – visitors for a century.

Crawford Art Gallery is committed to probing our shared histories and exploratory practice. As part of the major research project, *Building as Witness*, six project awards have been commissioned from creative practitioners who were invited, through a competitive Open Call process, to develop creative responses that engage with Crawford Art Gallery's buildings and environs from one hundred years ago. In November, composer **Fiona Linnane**, in collaboration with soprano Triona Walsh and the Youth Ensembles of Cork ETB School of Music, created *Cogarnach*.

Following a series of workshops, audiences were invited to a final performance of the work. The presentation in promenade style explored their responses to the spaces and stories they found through music, song, and sound. Two fully-booked performances of *Cogarnach* took place at Crawford Art Gallery on 26 November.

The remaining projects, to be realised in 2024, are: **Dominic Thorpe: Dark Dark Mouth**; **Jan McCullough: Night Class; Curtin // Keating: Sit Stand Smoke; Brian Teeling and Jennie Taylor: in the glow of a frozen flame**; and **Ursula Burke: These Fragile Monuments. Building as Witness** is kindly supported by the **Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media under the <b>Decade of Centenaries Programme 2012-2023**.

2023 has proved to be a busy, invigorating year of exhibition making and delivered projects, meeting the evolving demands of our audiences and the gallery's mission. The achievements of 2023 have enabled the gallery and its team to be poised to meet the challenges and opportunities of 2024.

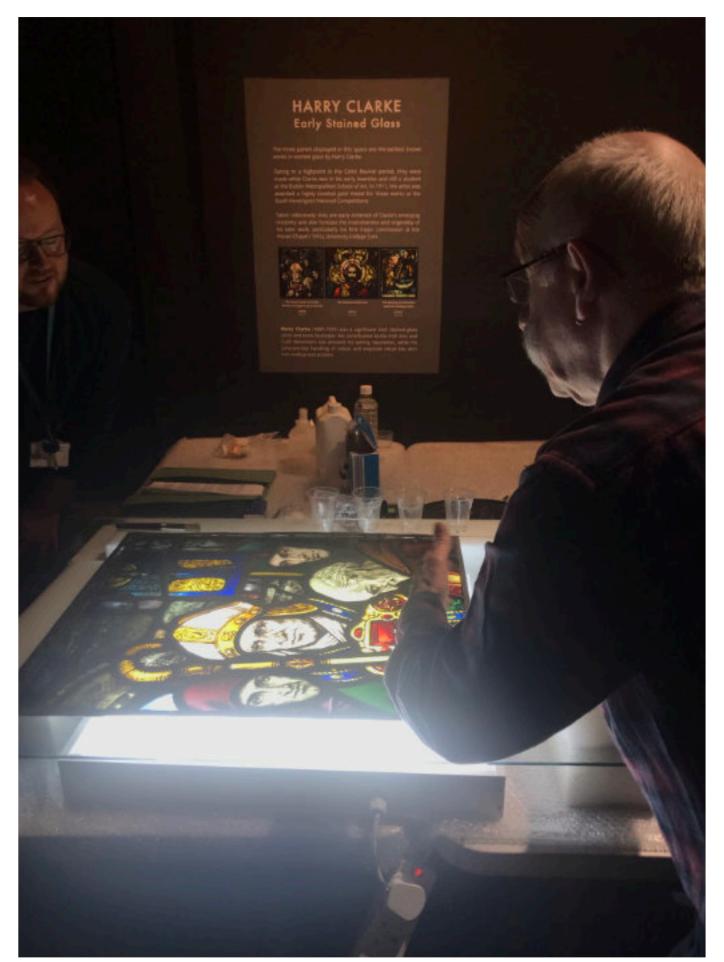
Restoration and preservation work was carried out on 39 artworks in the collection to preserve them into the future.

### HERITAGE STEWARDSHIP FUND: HARRY CLARKE STAINED GLASS PROJECT

Crawford Art Gallery was delighted to receive the Heritage Stewardship Fund 2023 from The Heritage Council to carry out essential conservation and reframing of three early stained-glass panels by Ireland's greatest stained glass artist, Harry Clarke. The three panels in question, *The God Head Enthroned* (1911), *The Meeting of St. Brendan with the Unhappy Judas* (1911), and *The Consecration of St. Mel, Bishop of Longford, by St Patrick* (1910) are rare examples of the artist's early work and demonstrate his remarkable originality. The first phase of the project took place in March and saw the panels being carefully removed from their existing lightboxes, cleaned and condition reported. Stained glass conservator, Philip Crook, carried out immediate consolidation measures to secure and consolidate weaknesses in the panels. The second phase took place in August, when Philip Crook carried out the final consolidation of lead and glass sections and fit the panels into their new bespoke LED lightbox frames, designed by Martlet Ltd. The frames use a custom-made APPLELEC LED system which uses simulated natural light wavelengths to prevent heat build-up, preserving these treasures into the future as well as enhancing their display.

### Learn & Explore

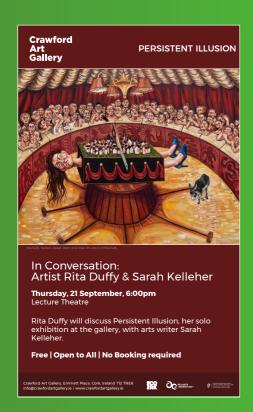
The Learn & Explore programme works to foster creative connection, engagement, collaboration and innovation, through a diverse programme of gallery workshops, tours, talks, events, outreach and long-term projects. These take place in gallery, and online or offsite in public, community, school and health settings.

Our central purpose is to support engagement with the national collection and the gallery programme of exhibitions and to broaden access to cultural expression within the public and civic space.

L&E programming is developed in consultation with artists, educators, community groups and cross-sectoral networks. We spotlight artists and modes of making through talks, workshops, online platforms and educational resource packs.

We are keen to recognise difference and increase equity of access; the focus of 2 of our long term commitments: Crawford Supported Studio for disabled artists and Lonradh a creative programme for people with memory loss and dementia, their families and carers. We believe that in proactively supporting inclusion and diversity in the arts, we benefit from a richer cultural experience that reflects our communities.

In 2023, we built upon our existing connections and increased our reach by inviting new groups to participate and engage with our programmes. We continued to work closely with the curators and exhibiting artists and planned regular talks and events tailored to each exhibition. We actively participated in local, national and international festivals and celebrations such as Imbolc, Lifelong Learning, Cork Mid-summer festival, Heritage Week and Culture Night.

### **EXHIBITION-LED PROGRAMMES**

2023 started with the closing tour of Corban Walker's As Far as I Can See led by Dr Sabine Kriebel and ended with To make open the eyes: Colour, Bauhaus, and Cork by artist Katherine Beug, a closing event for the exhibition SITE OF CHANGE: Evolution of a Building. For Drawing Room, artists Megan and Cassandra Eustace held a Drawing Clinic. The Poet William Keohane presented 'Boxing Day' an hour of poetry reading presentation, detailing experiences of gender transition and travelling abroad to access healthcare as part of **Behind the Scene**. The inaugural Irish language tour of the exhibition RADHARC: Perspectives in Print took place on March 5 for Seachtain na Gaeilge. Writers Laura McKenna and Éibhear Walshe discussed their approaches to world-building in historical fiction and biofiction in conjunction with the exhibition OTHER WORLDS: Harry Clarke Watercolours. Historian and co-curator of the exhibition Tom Spalding led tours of Site of Change as part of Cork Lifelong Learning. During the **Bodywork** exhibition artists Breda Lynch, Leanne McDonagh and Jennifer Trouton discussed their work and practise with exhibition curator Dawn Williams. Other talks included a powerful presentation by Anna Furse about Muscles, Voices from the Fields where artist Lisa Fingleton and the farmers involved in the project discussed the process and ideas behind the film and challenges that farmers are facing.

In September, Rita Duffy talked about her exhibition **Persistent Illusion** with Sarah Kelleher. As part of the gallery screening of 2023 **Artists' Film International** (AFI), film makers Jasmina Cibic and Michelle Deignan discussed and compared their respective practices of film making. Matt Smith's artist's talk as part of **Following Threads** was one of the last 2023 event in late November, Matt also engaged with students of MTU College and their tutor Kate Kelly.

### PROGRAMME FOR SCHOOLS AND THIRD LEVEL INSTITUTIONS

Guided visits tailored to the curriculum and supporting young people and teachers' own exploration were the back bone of the 2023 programme for schools. Suitable for students of all ages, abilities and backgrounds, the tours encouraged speaking confidently about art and the development of the students' viewpoints. From May until December, the upper gallery was a welcoming space for post-guided tours, for reflection, discussion and hands on activities. The availability of a room allowing for freer use of the gallery was particularly and favourably commented upon by teachers with students with additional needs.

Online resources accessible from our website are aimed at preparation ahead of a visit to the gallery or as teaching tools. We compiled resources sheets in collaboration with Anna Furse for Muscles (https://crawfordartgallery.ie/muscle-a-question-of-poweractivity-for-schools), with Matt Ryan, co-curator of the exhibition All Eyes on Us and with Ciara Wall for Persistent Illusion (https://crawfordartgallery.ie/art-as-socialcommentary-or-commentator/).

It was great to see third level institutions regularly engaging with our programmes of talks and exhibitions. Padraig Spillane, Pamela Hardesty, Sarah Kelleher, Sarah Foster and Maureen O'Connor of MTU CCAD, Kevin Taylor, Ray Lonergan and Debbie Godsell of ETB Douglas Street and Tramore road campuses, Sabine Kriebel, Jools Gilson and Lyndsey El Amoud of UCC visited various exhibitions with their students. In addition to our yearly engagement with the 3rd year UCC BEES students and professor Eoin Lettice, we were delighted to work with MTU 2nd year fine arts students for their art in context module again this year. Also among the repeat visits were UCC school of Nursing for their Visual Thinking Strategies module. Earlier in the year we were also delighted to facilitate visits from ETB Douglas Street Campus (St John Central College), the Cork College of Commerce and Tramore Road Campus.

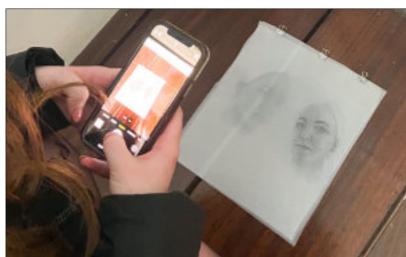

#### CHILDREN, YOUNG PEOPLE AND FAMILY PROGRAMMES

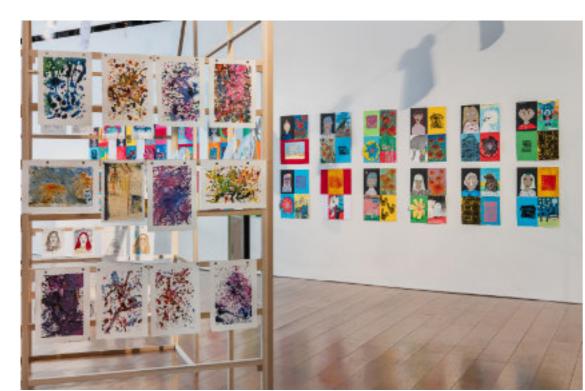
The L&E studio exhibition was a great opportunity to showcase elements of the L&E programme. The children and young people participating in the various art classes in 2023 focussed their attention and work with the exhibition in mind. Its opening in September was a reminder of the role that art can play in building connection and confidence; teaching techniques or the 'how to do,' and exploring imaginative ideas through drawing, painting, printmaking and 3d making. The L&E studio became the L&E studio Fête, a hive of activities on Culture Night.

We had a busy summer and made great use of the space offered in **Wiggle Room**, including free tours designed specifically for young children aged 4-8 as part of Cruinniú na nÓg festival, a programme of summer animation and drop-in sessions in July.

Throughout the year we organised one-off accessible workshops and other family-friendly free events marking yearly celebrations such as St Brigid's, St Patrick's and Halloween as well as seasonal festivals such as National Space Week (4 – 10 October) when the artist Seiko Hayase help our visitors to find their 9th planet of the Solar System.

We engaged with the Local Creative Youth Partnership for their creative youth link up, presented by Leanne McDonagh and youth arts groups from the travelling community in June. We partnered with Fiona Quinn and Cork ETB again in November on the occasion of the UN Children's Day which saw the galleries buzzing with the voices of young people.

With our partners from SECAD (Midleton), we welcomed members of the Ukrainian community and extended the invitation to other groups to meet in a relaxed setting.

#### **COMMUNITY PROGRAMME**

Our 3 durational initiatives: with disabled artists (Crawford Supported studios), with older people experiencing memory loss (Lonradh) and with younger participants from direct provision centres (Follow your Nose into Art) made good strides in 2023.

Crawford Supported studios was a particular focus of our attention all through the year with the official launch at 46 Grand Parade of compelling portraits on film cocreated with photographer/filmmaker Clare Keogh, available on a website: www.crawfordsupportedstudios.com. The artists members of the Studios were in the limelight with great media exposure on RTE 6 o'Clock news, RTE this is art, in the Irish Examiner, Evening Echo and Cork Independent. This was due to the combine efforts of the team at MTU and in particular Sarah Morey, Arts Officer and our own marketing team. In November we were delighted to host our first ever Supported Studios Meet Up, a day of presentations and demonstrations from Amy Begley and Jennifer Humphreys, of Connections Art Centre, Dublin. Brianna Hurley from KCAT Studios in Kilkenny, Florian Nolan an artist and autistic advocate with Suisha Arts at Cope Foundation Cork. Philip and Theresa, artists from DoubleTAKE Studio in Tallaght, presented their creative advocacy project. Fergus Hegerty a rapper and advocate for mental health closed out the afternoon performing a rap and inviting guests to sing with him. On November 30, for Meet the Artist @ Meta, Studio members Yvonne Condon, Brid Heffernan, Íde Ní Shúilleabháin, Tom O'Sullivan and Ailbhe Barrett travelled to the Meta/ Facebook Ireland HQ in Dublin to share their work, techniques and passion with Meta Staff and visitors. Activities for 2023 ended with a Christmas exhibition at MTU Crawford College of Art & Design, Grand Parade campus.

**Follow your Nose [into drawing],** the ongoing online access programme for young co-creators residing in direct provision centres or who have recently moved out of the centres was highlighted at the Anti-Racism Day in City Hall on May 26. In addition to weekly online sessions, there were visits to the gallery for the group in September and early October. Julie Forrester was invited to present the project at the Irish Museum Association Forum in Dublin and at the 2023 Arts in Education Portal Day in Limerick.

The **Lonradh** programme for older people experiencing memory loss held sessions in St Finbarr's hospital, at the Alzheimer Café and welcomed groups from nursing homes in the gallery. The Lonradh booklet was ready just in time for the official opening of the L&E studio exhibition. Devised with the aim of reaching people who cannot travel to the gallery, the booklet presents eight different art sessions, introducing a variety of techniques and materials. 200 copies were distributed in St Finbarr's hospital, at the Alzheimer Café, at Westgate Foundation, in nursing homes and to health professionals.

In 2023 the Gallery's social media strategy played a critical role in maintaining and growing our connection with the public. Facebook has been the fastest growing social media platform at 10.7%, which is up from a 6% increase the year before. Instagram also continues to grow at a steady rate at 9.7%. Due to a change in ownership of Twitter and many changes to the platform, we have seen a drop in following as a large number of accounts have been deleted, however we have still succeed in growing our audience at a rate of 3%.

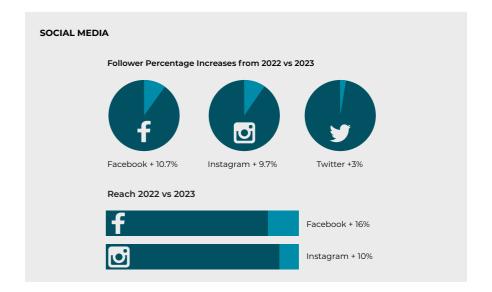

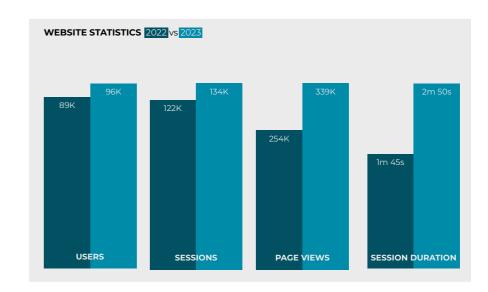

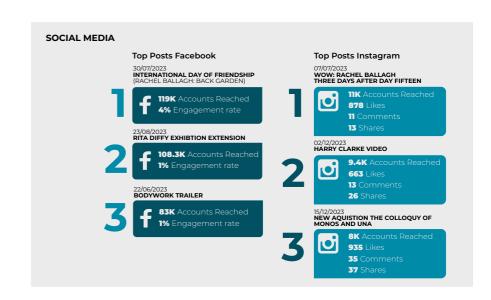

As mentioned above, a highlight was Culture Night 2023 with the gallery exceeded 2022's audience numbers with a record number of 4,110 culturally curious visitors to the gallery!

### **TOURS**

Crawford Art Gallery hosted a number of themed tours and guest tour guides across 2023. These themes included:

- · Women & Mythology
- Irish language
- Mindfulness tours
- Great Irish Artists in the Collection
- LGBTQI+ Tour with Candy Warhol

Themed tours are a great way to show the collection through different context, and bring new audiences to the Gallery.

Public tours on Sunday & Bank Holiday and Thursday evenings have continued to be popular with both new guests and repeat visitors. We were grateful for the continued support of the Night-Time Economy and funded by The Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media to continue our Thursday evening tours, allowing us to reach a new audience and keep our doors open until 8pm. Tours are marketed through a social media ad campaign, listings, and exterior signage. Social media, the website and exterior signage have been the most popular way of communicating tours to the public, and we have seen many repeat visitors returning for tours.

#### MARKETING MATERIALS:

The Marketing & Communications team continues to create marketing materials such as banners on the Gallery railings, which research has shown are key for passersby and the Gallery.

We have continued to produce a monthly newsletter, monthly targeted mailshots, design for adverts both for the Gallery brand and specific exhibitions as well as a quarterly brochure which is well received by Gallery visitors and also disseminated in the city.

Crawford Art Gallery produced a specific brochure targeting international and domestic tourists displayed on Glance advertising stands, in over 500 locations. This brochure targets domestic and international tourists.

In 2023 we begun working on our interim rebrand for when the gallery closes in 2024, we have begun workshops with staff and external stakeholders to look at our current brand and begin thinking about our brand while we are closed to the public.

#### IRISH LANGUAGE ADVERTISING

In December 2021, the Official Languages (Amendment) Act, 2021 was enacted. The Amendment aims to strengthen the Official Languages Act 2003. As a result, a new statutory obligation for public bodies came into effect, in relation to advertising, general communications and commercial communications.

This effected the Marketing Team as it meant that:

A public body shall ensure that

- (a) at least 20 per cent of any advertising placed by the body in any year shall be in the Irish language, and
- (b) at least 5 per cent of any monies spent on advertising by the body in any year shall be in the Irish language through Irish language media.

In 2023, Crawford Art Gallery exceeded these targets, with 1 in 5 of our advertisements in the Irish language or dual language, this included radio ads, press, exterior banners and digital advertisements. We also exceeded our 5% target by reaching 16.7%. This means that 16.7% of our marketing spend went back into Irish language companies.

## Friends

Supporting the arts and those working within the arts industry has been at the core of our mission since its foundation over 35 years ago.

The Friends of the Crawford Art Gallery play a valuable role in providing a social, engaging and fun programme for those in the community who share an appreciation of the arts and a love for Crawford Art Gallery. In 2023 The Friends of Crawford Art Gallery secured charity status with the Charities Regulator.

The Friends varied events programme aims to highlight new creative thinking and processes and explore traditional techniques.

The Friends Newsletter continued to bring news of Friends events, events/exhibitions/talks etc in Crawford and other local exhibitions to members on a fortnightly basis throughout 2023. The newsletter included many of our CorkAbout! videos which were created to bring news of new local artists to our members. In particular the CorkAbout! videos proved very useful as a way of following the Graduation exhibitions of art students in Cork Art Colleges/ Schools through the Emerge Award.

**Friends Workshops**. The Friends took to creating their own artworks in various hands-on workshops throughout 2023.

Friends Pod Tours remained extremely popular with Friends throughout 2023. A total of 6 Pod Tours were run throughout 2023 with curators Dr Michael Waldron, Dawn Williams and Anne Boddaert. These tours gave Friends the opportunity to engage with exhibitions and spend time with the curators to discover insights into details surrounding the works and the artists behind the works. Numbers attending ranged from 7-28 and covered the exhibitions, 'Behind The Scenes', 'Radharc', 'Body Work', 'Persistent Illusion, 'Following Threads', and a bespoke exclusive 'Behind The Scenes/Backstage Tour' with Dr Tom Spalding for the Friends Committee Members in appreciation of their support on the Friends Committee.

The Friends Spring & Autumn 2023 Lecture Series remain extremely popular with a wide range of lecture topics facilitated by artists and lecturers in their field.

The Emerge 2023 Award was a highlight of the year for the Friends, this is the third time the Friends have been able to support an emerging artist. Through the Emerge Award, an initiative of Cork Craft and Design's Cork Craft Month, the Friends have been able to reach out to the final year students in five of Cork's Art schools and offer support in the form of a six-month studio place in the creative hub Benchspace to the overall winner of the award. This studio space offers the winning artist the space, equipment, time and expertise they need to develop their skills as they venture out from the protective surroundings of art school. Through our CorkAbout! videos we accompanied Emerge Award curator Aysegul visiting the participating art colleges to view the graduates work and recorded these visits for the members to enjoy. The winner of the Emerge Award 2023 was Chris Whelan whose Dragon Fly Desk was a firm favourite with Friends due to Chris' considered design. Chris was awarded a Students Makers Award with Design & Crafts Council of Ireland.

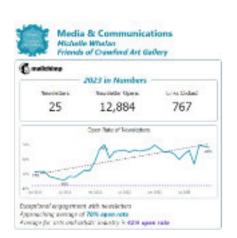

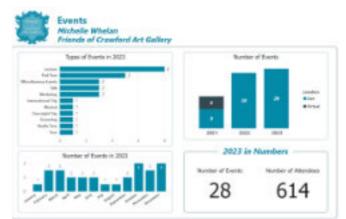

## INTRODUCTION

Crawford Art Gallery is a National Cultural Institution located in a significant heritage building in the heart of Cork City, dedicated to the visual arts, both historic and contemporary. It is in part distinguished by being the only National Cultural Institution (NCI) located in its entirety outside of Dublin.

Crawford Art Gallery is actively contributing to Cork City and the wider region's ambitious plans for growth and internationalisation. The Crawford Art Gallery has a distinct and compelling story, physically it is comprised of three interconnected buildings of distinct historic origin, derivation, and style, reflecting the extraordinary evolution of the buildings towards the cultural institution they house today.

They incorporate the former Customs House of 1724, extensively altered and expanded to the South and West by prominent architect Arthur Hill to form the ground- breaking Crawford School of Science and Art in 1884. For much of the 20th century, the school operated as classrooms, workshops, and studios, with sculpture and painting galleries, a lecture theatre, offices, and ancillary support facilities. The Crawford School of Art operated on this site for 96 years.

In 1979, the School of Art relocated to Sharman Crawford Street and the premises that remained became the Crawford Municipal Art Gallery. Following an architectural competition, Dutch architect Erick van Egeraat carried out intermediary works during 1998 – 2000 taking under cover the courtyard between the South and West wings.

Crawford Art Gallery was designated a National Cultural Institution in 2006. As a Notfor-Profit organisation it collects, safeguards, holds in trust, researches, develops and interprets collections of original objects and original objects on loan, for the public benefit.

## The main objects for which the company is established are:

- 1. To advance education by developing and promoting the practice of art, sculpture, and design and in the fine arts and applied arts generally and to promote the Crawford Art Gallery Cork as an educational centre for the arts and as a major cultural and artistic centre.
- 2. To advance education by providing facilities for cultural and artistic exhibitions, performances, displays, demonstrations, conferences, lectures, tours, visits, functions, and related activities and to engage in the promotion of such cultural and artistic activities.

The Crawford Art Gallery organises an ambitious programme of Exhibitions, Projects and a rich and engaging Learn and Explore programme which provides diverse audiences with an opportunity to interact and engage with art and artists in a range of extraordinary contexts. The Crawford Art Gallery is committed to fostering recognition, critical assessment, and acknowledgement of Irish and international art practices though its programming and collecting ethos.

## INTRODUCTION- CONTINUED

The collection comprises of almost 4,000 works, ranging from eighteenth-century Irish and European paintings and sculptures, to contemporary art and video installations.

The collection is made available through exhibitions at Crawford and other venues nationally and internationally, by digital access, through the Learn and Explore programmes and various publications, talks, lectures, and broadcasts that seek to provide a unique experience to everyone who engages with the Gallery.

The environment in which Crawford Art Gallery is operating is changing rapidly and there is an unprecedented opportunity to redefine the core purpose and increase impact.

There are exciting new opportunities to connect with audiences and to find new ways to ensure that the work has a deeper engagement with our audiences and that it reflects the narratives and culture of our time.

Digitisation has enabled a wider access to the work and collection and ensures that the work can be available for research and public interest.

There is a strong commitment to best practices in collection management and to significantly expanding the collection.

Equally, there is also a commitment to create opportunities for artists to collaborate with the collection and the building to create new works and to support the development of artists practice through exhibitions and projects and print materials. ## STRUCTURE GOVERNANCE AND MANAGEMENT

Crawford Art Gallery (CAG) is a National Cultural Institution and a Company Limited by Guarantee, registered in the Republic of Ireland. As such it must observe and comply with the Governing Laws of the Republic of Ireland and applicable overarching EU Laws and Regulations, including compliance with the Companies Act 2014.

Crawford Art Gallery's Constitution and Charitable Objects as required by law are set out in the *Memorandum & Articles of Association*.

As a Public Body under the aegis of the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media, Crawford Art Gallery must comply with the regulatory framework and codes of practice issued by the Department of Public Expenditure, NDP Delivery and Reform (DPER) – where applicable. The current Code of Practice for the Government of State Bodies is effective from September 2016, with the addition of Code Annex (2020) on Gender Balance, Diversity, and Inclusion.

### **ORGANISATION STRUCTURE AND RESPONSIBILITIES**

### Board

The Chair and Directors (who are the members of the company) are appointed by the Minister for Tourism, Culture, Arts, Gaeltacht, Sport and Media and normally serve for a period of 5 years and may be reappointed for one further term. The Chair and the Board of Directors are non-executive directors of the company. The number of directors was established at 12. All board positions are approved by the Minister, 9 through the PAS system as well as one a nominee of Cork County Council, one a nominee of Cork City Council and Cork City CEO who is ex-officio.

The identification of persons suitable for appointment as directors is managed by the Public Appointments Service (PAS) under the 'Guidelines on Appointments to State Boards (2014)'.

### **Conduct and Business of the Board**

A full agenda with appropriate documentation is circulated on the Friday prior to board meetings and decisions taken are recorded in the minutes.

The Board may from time to time appoint special committees to consider items of

detail between meetings of the Board.

Board members will debate all issues in a friendly and measured manner encouraging contributions and consensus.

## STRUCTURE GOVERNANCE AND MANAGEMENT – CONTINUED

### **Role of the Chair**

The Chair is appointed by, and accountable to, the Minister and is a non-executive officer of the company. The Chair, as an officer under company law, carries the responsibilities of other officers of the company – the Board. In addition, the *Code of Practice for the Governance of State Bodies* states that the Chair is responsible for leadership of the Board and ensuring its effectiveness on all aspects of its role.

The Code further states that s/he should display high standards of integrity and probity and set expectations regarding culture, values, and behaviours and for the tone of discussions at board level. Other provisions in the Code relating to the role of the Chair include:

- Effectively managing the role of the Chair in the Board agenda with the Gallery Director and ensuring that adequate time is available for discussion of all agenda items, particularly strategic issues.
- Promoting a culture of openness and debate within the Board by facilitating the effective contribution of key management and all board members.
- Ensuring that the Board receives accurate, timely and clear information. The Chair should also ensure effective communication with all relevant stakeholders.
- Advising the Minister in relation to specific skills required by the Board in advance of a time when vacancies are due to arise.
- Ensuring through the Secretary that there are good information flows within the Board and its committees and between senior management and board members as well as facilitating induction, mentoring, and assisting with ongoing professional development as required.
- Furnishing to the Minister, in conjunction with the annual report and financial statements, a comprehensive report covering Crawford Art Gallery and reporting to the Minister on the effectiveness of the company's system of internal control.
- Acting on the results of the Board's annual self-evaluation.
- Agreeing and overseeing the Director's short and long-term performance objectives and facilitating his/her professional development.

## Other responsibilities for the Chair include:

- Ensuring, with the support of the Company Secretary, that the Board meets in accordance with its Memorandum and Articles of Association and complies with statutory responsibilities.
- Representing the company as appropriate in dealings with the Minister and other key Stakeholders; Keeping the Minister informed of all material matters relating to the company and ensuring that the Board, in reaching decisions, takes proper account of guidance provided by the Minister.
- Being available to Oireachtas Committee to discuss their role and view on future contribution of the company.

## STRUCTURE GOVERNANCE AND MANAGEMENT - CONTINUED

### **ROLE OF THE BOARD**

The Board has collective responsibility for promoting the success and long-term sustainability of the company. Its key roles include governing the business of the organisation and supporting the company achieve its Vision and Mission. The Board provides strategic guidance to the Director and the senior management team (SMT) and monitors the activities and effectiveness of the organisation.

### **BOARD - DIRECTORS AND OFFICE RESPONSIBILITIES**

As directors and officers of the company in law, the Board accept specific duties as set out in the Companies Act 2014 as well as maintaining and promoting the highest standards of personal probity and good governance specifically:

- The Board have a duty to act in good faith and in the best interests of Crawford Art Gallery; to act in accordance with the constitution; not to benefit from the company's property; and to avoid conflicts of interest.
- The directors who are the Board members of Crawford Art Gallery are required to comply with the provisions in the Companies Act 2014. Directors are required to sign a statement of compliance on their appointment in line with the Act.
- Directors must have regard to the interests of employees.
- Directors must disclose any interest in contracts made by Crawford Art Gallery.
- Board members must report any incidences of non-compliance with the Act or other statutory obligations to their fellow board members and the Minister.

The fiduciary duties of board members to Crawford Art Gallery include:

- To act in good faith in what the Board member considers to be in the interest of the company.
- To act honestly and responsibly in relation to the conduct of the company's affairs
- To act in accordance with Crawford Art Gallery constitution and exercise his/her powers only for the purposes allowed by law.
- Not to benefit from or use Crawford Art Gallery property, information, or opportunities for his or her own or anyone else's benefit unless the constitution permits or a resolution is passed in a general meeting.
- Not to agree to restrict the Board member's power to exercise an independent judgment unless this is expressly permitted by the company's constitution.
- To avoid any conflict between the Board member's duties to Crawford Art
  Gallery and the Board member's other interests unless the Board member is
  released from his or her duty to Crawford Art Gallery in relation to the matter
  concerned.

## STRUCTURE GOVERNANCE AND MANAGEMENT - CONTINUED

 To exercise the care, skill and diligence which would be reasonably expected of a person in the same position with similar knowledge and experience as a board member.

The Board are responsible for reviewing and approving the strategic plan for Crawford Art Gallery before it is submitted to the parent department for approval. The Board considers regular reports from the Director on the implementation of the Plan and holds the Director and the senior management team (SMT) accountable for its delivery.

### **BOARD - GOVERNANCE & POLICY**

The Board, and where necessary through appropriate sub-committees, will support the Director and the SMT in ensuring effective governance and control of the company through:

<u>Governance</u>. The Board ensures that the governance and accountability arrangements are robust and effective across the organisation in line with the applicable Code and Regulations.

<u>Policy and Procedures</u>. The Board are responsible for reviewing, approving and adopting all major policy and procedures that influence the control and governance at CAG. From time to time throughout the year the Director proposes policy initiatives or reviews to the Board for discussion and adoption.

<u>Oversight & Delegation</u>. The Board have an oversight responsibility to ensure effective organisational delivery and planning at Crawford Art Gallery by reviewing and approving the oversight agreement between Crawford Art Gallery and the Department and delegating responsibility to the Director, the SMT and staff of Crawford Art Gallery for the day-to-day management of the organisation.

## **BOARD - RESOURCES**

The Board has specific responsibility to ensure there is an effective and controlled use of resources and will:

<u>Budget:</u> Adopt an annual budget in alignment with the strategy, based on prudent expectations on grant funding, commercial, fundraising and programme revenues and controlled operational overheads including staffing costs.

<u>Report:</u> Ensure that the content and level of financial reporting is timely and transparent and gives a true and fair reflection of the financial health of the organisation and which supports understanding and decision making.

<u>Control</u>: Approve all major expenditure items in line with the Gallery's authorities matrix.

## STRUCTURE GOVERNANCE AND MANAGEMENT - CONTINUED

<u>Review and Approve</u>: Engage with the Director on matters of human resources and review the organisational workforce plan in line with the requirements of the Department. The Board will review and approve all senior appointments and may choose to sit on interview panels for same.

## **BOARD - ADVOCACY AND SUPPORT**

The Board have a key role in promoting the work of Crawford Art Gallery with external stakeholders and will:

<u>Advocate.</u> As champions of Crawford Art Gallery's vision and mission, the Board will act as advocates for the organisation by connecting passion for the organisation with their influence with stakeholders and in the community.

<u>Participate & Support</u>. The Board will support the Director in a general way by attending Crawford Art Gallery events and informing the Director of any feedback.

## **ROLE OF THE DIRECTOR**

The Director of Crawford Art Gallery is appointed by, reports to, and is accountable to the Board of Crawford Art Gallery. The Board delegates responsibility to the Director to direct and manage the day-to-day business of the organisation, through the senior management team and staff at Crawford Art Gallery. The Director is an executive officer of the company and is not a board director of the Company.

The Director attends board meetings to inform and report to the Board on the activities of Crawford Art Gallery and is entitled to speak and provide advice at any meeting of the committee that he/she attends.

## Responsibilities include:

<u>Strategy</u>. The Director with the senior management team is responsible for developing the organisational strategy and ensuring that the strategy is aligned to the company's vision, mission and values.

<u>Cultural Leadership</u>: The Director has the duty to promote and advocate Crawford Art Gallery on the national and international level and align the work of Crawford Art Gallery in this context.

<u>Informing</u>. The Director keeps the Chair informed on an ongoing basis regarding developments in the organisation and any significant issues arising.

<u>Financial Management</u>. The Director is responsible for managing the annual budget and activities of the organisation in line with the annual plans and budgets approved by the Board and keeps the Board informed of progress in this regard via the Finance and Legal and Audit and Risk Committees.

## STRUCTURE GOVERNANCE AND MANAGEMENT – CONTINUED

<u>Human Resources</u>. The Director is responsible for the recruitment and management of staff and for ensuring compliance with statutory and administrative requirements in relation to the approval of the number, grading and conditions of appointment of all staff. The Director has a duty to support, manage and develop staff in line with Crawford Art Gallery's objectives.

<u>Fire, Health & Safety</u>. The Director allocates specific responsibility for health & safety to a senior staff member and is responsible, along with the Board for ensuring adherence to the highest standards of health & safety at Crawford Art Gallery in line with the safety statement.

<u>Performance</u>. At the end of each year, the Director presents to the Board a review of performance of Crawford Art Gallery against the annual plan to inform policy and plans for the forthcoming year.

<u>Oversight Agreement</u>. The Director, along with the Board, agrees the annual performance contract with the parent Department as set out in the oversight agreement. The Director reviews annually that the terms of agreement have been met

<u>Report</u>. The Director is required to bring the following issues to the attention of the Chair and Board.

- Any legal claim against Crawford Art Gallery.
- Significant human resources or industrial relations issues.
- Unresolved disputes with a third-party organisation.
- Risks identified affecting company assets/property ownership, insurance, health and safety.
- Issues raised by bankers, solicitors, auditors or government relating to governance.
- Issues that have the potential to threaten or damage the reputation of the company.
- Any significant proposed change in established policy, plans or practice of the company.
- Issues relating to an identified conflict of interest among staff.
- Any issue relating to staff compliance with travel and subsistence policies.

## **Assets and Liabilities for Financial Position**

The total assets of the business have increased by €2,289,706 to €43,651,549; the total liabilities have decreased by €685,462 to €987,859 resulting in an increase in net assets of €2,975,168 to €42,663,690.

## **Events after the Balance Sheet date**

There have been no significant events affecting Crawford Art Gallery since the year end.

### **Going Concern**

The Gallery has made a surplus for the financial year of €334,123(2022: €94,254) and had net assets of €42,663,690 (2022: €39,688,522) at the balance sheet date. Cash flow forecasts prepared by management indicate that the Gallery is expected to have sufficient cash flows to continue its operations for a period of at least 12 months from the date of signing the financial statements.

Taking account of these circumstances, the directors consider it appropriate to prepare the financial statements on a going concern basis. Accordingly, these financial statements do not include any adjustments to the carrying amount or classification of assets and liabilities that may arise if the Gallery was unable to continue as a going concern.

## **FUTURE DEVELOPMENTS**

The Crawford Art Gallery has commenced a major redevelopment programme for the Crawford Art Gallery building at Emmet Place, Cork. The redevelopment project will entail the conservation and refurbishment of the existing public and gallery spaces and further enhancements to the gallery to include new exhibition and storage facilities, new learn and explore spaces and an overall enhanced visitor experience including a major reorientated entrance onto Emmett Place.

The current phase of this redevelopment project will culminate in the finalisation and presentation of the final business case which is expected in the latter half of 2024. The overall approved funding from the Department of Tourism Culture Arts Gaeltacht Sport and Media for this phase of the project, i.e. the preparation of the Final Business Case is €6,913,120. The costs incurred to date in the financial statements is €5,057,387. The construction phase of the project is expected to commence in late 2024. This project is being funded by the Department of Tourism Culture Arts Gaeltacht Sport and Media.

## STATEMENT ON INTERNAL CONTROL

## **Scope of Responsibility**

On behalf of the Crawford Art Gallery Cork, we acknowledge the Board's responsibility for ensuring that an effective system of internal control is maintained and operated. This responsibility takes account of the requirements of the Code of Practice for the Governance of State Bodies (2016).

## **Purpose of the System of Internal Control**

The system of internal control is designed to manage risk to a tolerable level rather than to eliminate it. The system can therefore only provide reasonable and not absolute assurance that assets are safeguarded, transactions authorised and properly recorded, and that material errors or irregularities are either prevented or detected in a timely way.

The system of internal control, which accords with guidance issued by the Department of Public Expenditure, NDP Delivery and Reform, has been in place in Crawford Art Gallery for the year ended 31 December 2023 and up to the date of approval of the financial statements.

## **Capacity to Handle Risk**

Crawford Art Gallery has an Audit and Risk Committee (ARC) comprising four board members and one external member, with financial and audit expertise, one of whom is the Chair. The ARC met 4 times in 2023. Crawford Art Gallery has also established an internal audit function which is adequately resourced and conducts a programme of work agreed with the ARC.

The ARC has developed a risk management policy which sets out its risk appetite, the risk management processes in place and details the roles and responsibilities of staff in relation to risk. The policy has been issued to all staff who are expected to work within Crawford Art Gallery's risk management policies, to alert management on emerging risks and control weaknesses and assume responsibility for risks and controls within their own area of work.

## **Risk and Control Framework**

Crawford Art Gallery has implemented a risk management system which identifies and reports key risks and the management actions being taken to address and, to the extent possible, to mitigate those risks.

A Risk Register is in place which identifies the key risks facing Crawford Art Gallery and these have been identified, evaluated, and graded according to their significance. The Risk Register is reviewed and updated by both the ARC and the Board. The outcome of these assessments is used to plan and allocate resources to ensure risks are managed to an acceptable level.

## Financial Statements STATEMENT ON INTERNAL CONTROL

### **Risk and Control Framework - continued**

The Risk Register details the controls and actions needed to mitigate risks and responsibility for operation of controls assigned to specific staff. We confirm that a control environment containing the following elements is in place:

- Procedures for all key business processes have been documented,
- Financial responsibilities have been assigned at management level with corresponding accountability,
- There is an appropriate budgeting system with an annual budget which is kept under review by senior management,
- There are systems aimed at ensuring the security of the information and communication technology systems,
- There are systems in place to safeguard the assets.

## **Ongoing Monitoring and Review**

Formal procedures have been established for monitoring control processes and control deficiencies are communicated to those responsible for taking corrective action and to management and the Board, where relevant, in a timely way. We confirm that the following ongoing monitoring systems are in place:

- Key risks and related controls have been identified and processes have been put in place to monitor the operation of those key controls and report any identified deficiencies.
- Reporting arrangements have been established at all levels where responsibility for financial management has been assigned, and
- There are regular reviews by senior management of periodic and annual performance and financial reports which indicate performance against budgets/forecasts.

## **Procurement**

There were no instances of non-compliant procurement during 2023.

## **Annual Review of Controls**

We confirm that the Board conducted an annual review of the effectiveness of the internal controls for 2023 in March 2024.

## 1. ACCOUNTING POLICIES

The basis of accounting and significant accounting policies adopted by Crawford Art Gallery Cork are set out below. They have all been applied consistently throughout the year and for the preceding year.

## a) General Information

Crawford Art Gallery Cork is a company incorporated in Ireland under the Companies Act 2014. The address of the registered office is Crawford Art Gallery, Emmet Place, Cork, T12 TNE6. Crawford Art Gallery Cork is a Public Benefit Entity (PBE). The nature of the company's operations and its principal activities are set out in Governance Statement and Board Members' Report on page 5-7. Crawford Art Gallery Cork's primary objective as set out in (Part 2) of the Memorandum of Association are as follows:

- (a) to advance education by developing and promoting the practice of art, sculpture and design and in the fine arts and applied arts generally and to promote the Crawford Art Gallery Cork as an educational centre for the arts and as a major cultural and artistic centre.
- (b) to advance education by providing facilities for cultural and artistic exhibitions, performances, displays, demonstrations, conferences, lectures, tours, visits, functions and related activities and to engage in the promotion of such cultural and artistic activities.

## b) Statement of Compliance

The financial statements of Crawford Art Gallery for the year ended 31 December 2023 have been prepared in compliance with the applicable legislation, and in accordance with the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland ((FRS 102) - (Charities SORP (FRS102).

## c) Basis of Preparation

The financial statements have been prepared on a going concern basis and under the historical cost convention, except for certain assets and liabilities that are measured at fair values as explained in the accounting policies below. The financial statements are in the form approved by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media and Charities SORP and have been prepared in compliance with the requirements of the Companies Act 2014. The following accounting policies have been applied consistently in dealing with items which are considered material in relation to Crawford Art Gallery Cork financial statements.

## ACCOUNTING POLICIES – CONTINUED

## d) Charities SORP and Transitional Arrangements

The financial statements have been prepared in accordance with Charities SORP. The effective date for the adoption of Charities SORP was 1 January 2022. No prior year adjustments have arisen because of the adoption of Charities SORP.

## e) Going Concern

The Gallery has made a surplus for the financial year of €334,123 (2022: €94,254) and had net assets of €42,663,690 (2022: €39,688,522) at the Balance Sheet date. Cash flow forecasts prepared by management indicate that the Gallery is expected to have sufficient cash flows to continue its operations for a period of at least 12 months from the date of signing the financial statements.

The directors consider it appropriate to prepare the financial statements on a going concern basis. Accordingly, these financial statements do not include any adjustments to the carrying amount or classification of assets and liabilities that may arise if the Gallery was unable to continue as a going concern.

## f) Revenue

Income is distinguished as either restricted income or unrestricted income. Income is accounted for as restricted funds when so specified by the contributor. Such funds receivable for restricted purposes are dealt with through the Statement of Financial Activities – restricted funds, on a performance basis. Expenditure from these funds is dealt with in the specific funds through the Statement of Financial Activities.

Income is recognised by inclusion in the Statement of Financial Activities only when the Crawford Art Gallery Ltd is legally entitled to the income, any performance conditions attached to the income are met, the amounts involved can be measured with sufficient reliability and it is probable that the income will be received.

Funds receivable for which there is no specific purpose specified by the contributor, are dealt with in the Statement of Financial Activities – unrestricted funds, on a performance basis.

## 1. ACCOUNTING POLICIES - CONTINUED

## Oireachtas Grants

Oireachtas grants are recognised on the performance basis as required under the Charities SORP. The performance basis requires that all performance related conditions are met before the income can be recognised. Additionally further conditions as to entitlement, probability, measurement must also be satisfied before the income is recognised in accounts. Should a grant have no performance conditions then the conditions as to entitlement, measurement and probability apply.

## Other non-Government grants

Non-Government grants are recognised on an accruals basis once the conditions relating to probability, entitlement and measurement are met.

## Other Revenue

Income from donations, grants, sponsorships, rent and that derived from tours and educational workshops is recognised when there is an entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received, and the amount can be measured reliably.

## Donations from the public

Monetary donations from the public are recognised on receipt.

### Interest income

Interest income is recognised on an accruals basis using the effective interest rate method.

## **Donations of Goods and Services**

Donations of goods and services are recognised upon receipt at fair value. Fair value is the cost of acquiring such goods and services. Such donations are recognised both as income and expenditure in the Statement of Financial Activities.

### G) Donated Artwork

Donated Artwork received in the normal activity of the Gallery is recognised as Income within the Statement of Financial Activities. Donated assets are valued at fair value.

## h) Tangible and Intangible Assets

Property, plant & equipment are recorded at cost less accumulated depreciation, adjusted for any provision for impairment. Depreciation is provided on all property, plant & equipment, except for Heritage Assets, at rates estimated to write off the cost less the estimated residual value of each asset on a straight-line basis over their estimated useful lives, as follows:

Improvement to leasehold premises	2% Straight Line
Equipment	12.5% Straight Line
Furniture and fixtures	12.5% Straight Line
Digital archive	12.5% Straight Line

Residual value represents the estimated amount which would currently be obtained from disposal of an asset, after deducting estimated costs of disposal, if the asset were already of an age and in the condition expected at the end of its useful life.

If there is objective evidence of impairment of the value of an asset, an impairment loss is recognised in the Statement of Financial Activities in the year.

## (i) Heritage Assets

Donated artworks are held at valuation. Initial valuations are carried out by the Gallery Director with reference to experts in particular areas, as well as collecting auction house results and recent sales achieved for particular works. Purchased art works and restricted artworks are held at cost. From 2022, the value of heritage assets will be reviewed on a periodic and sample basis and the resulting difference between the book value and revalued amounts will be recorded in the accounts. At each reporting date the Gallery determines whether any of its heritage assets are impaired.

## (j) Inventory

Inventories are measured at the lower of cost or estimated selling price less costs to complete and sell.

### (k) Receivables

Receivables are recognised at fair value, less a provision for doubtful debts. The provision for doubtful debts is a specific provision and is established when there is objective evidence that Crawford Art Gallery Ltd will not be able to collect all amounts owed to it. All movements in the provision for doubtful debts are recognised in the Statement of Financial Activities.

## L) Employee Benefits

## **Short Term Benefits**

Short term benefits such as holiday pay are recognised as an expense in the year, and benefits that are accrued at year-end are included in the payables figure in the Balance Sheet.

## **Retirement Benefits**

In July 2011 agreement was reached with the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media and the Cork Education and Training Board to transfer the retirement benefit contributions of staff back to the Cork Education and Training Board scheme and thus no further net liability for pension entitlements attaches to the Gallery.

New entrant staff employed by the company after 1 January 2013 are members of the Single Public Service Pension Scheme in accordance with Public Service Pensions (Single Scheme and Other Provisions) Act 2012. The company makes the necessary deductions from salaries for staff who are part of the scheme. Employee contributions are transferred to the Department of Public Expenditure, NDP Delivery and Reform monthly in accordance with the Public Service Pensions (Single Scheme and Other Provisions) Act 2012. The pension liability of €834,000 and corresponding asset from the State of €834,000 have been recognised in the Balance Sheet

Pension costs reflect pension benefits earned by employees and are shown net of staff pension contributions which are remitted to the Department of Public Expenditure, NDP Delivery and Reform. An amount corresponding to the pension charge is recognised as income to the extent that is recoverable and offset by grants received in the year to discharge pension payments.

Actual gains or losses arising on scheme liabilities are reflected in the Statement of Comprehensive Income, and a corresponding adjustment is recognised on the amount recoverable from the Department of Tourism, Culture, Arts, Gaeltacht, Sports and Media.

The Financial Statements reflect, at fair value, the assets and liabilities arising from the Gallery's pension obligations and any related funding and recognises the costs of providing pension benefits in the accounting periods in which they are earned by employees. Retirement benefit scheme liabilities are measured on an actuarial basis using the projected unit credit method.

## (I) Capital Account

The capital account represents the amount of unamortised income used for capital purposes along with the transfers of donated artwork from the Statement of Financial Activities.

## (m) Critical Accounting Judgements and Estimates

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the amounts reported for assets and liabilities as at the Balance Sheet date and the amounts reported for revenues and expenses during the year. However, the nature of estimation means that actual outcomes could differ from those estimates. The following judgements have had the most significant effect on amounts recognised in the financial statements.

## **Key source of estimation – Pension scheme**

The cost of defined benefit pension plans are determined using actuarial valuations. The actuarial valuation involves making assumptions about discount rates, future salary increases, mortality rates and future pension increases. Due to the complexity of the valuation, the underlying assumptions and the long-term nature of these plans, such estimates are subject to significant uncertainty.

### **Key source of estimation – Estimated Useful Lives**

Determining the annual depreciation charge and grant amortisation amount for each asset category requires the company to make an estimate of the estimated useful lives of its assets over which to depreciate the asset or amortise the grant.

## (n) Valuation of Artwork Donated

Donated assets are valued by the Gallery Director through referencing to experts in particular areas, as well as through collecting auction house results and recent sales achieved for particular works of art.

Initial recognition of donated artwork is at valuation, as valued by the Gallery Director. The initial valuations are carried out by refencing and collating auction house results for similar works of art and referring to experts when required. At each reporting date all artwork is assessed for impairment for physical deterioration, breakage, or doubts as to their authenticity.

The Gallery holds circa 4,000 works in a range of different media, mainly oil on canvas, watercolour on paper, stone and metal sculptures and stained glass. The scope of work extends from eighteenth century Irish and European Paintings, eighteenth century Sculptures through to contemporary video installation.

All proposals regarding the acquisition of new works for the Crawford Art Gallery collection, whether by purchase, gift, bequest or other means are discussed and evaluated by the Gallery Team. The proposal is then reviewed by the Artistic Policy Sub-Committee, who present same, for approval to the Board. Works of Irish Artists of the 20th and 21st centuries are central to the collection. The contemporary collection at the Crawford is focused heavily, but not exclusively on Irish Art. All acquisitions are documented in accordance with Gallery procedures.

The Gallery commits to caring for works in the collection in perpetuity, however unique circumstances may necessitate an object requiring to be de-accessioned. The gallery has a De-accession and Transfer Policy governing this process and any de-accession requires approval from Gallery Team, Artistic Policy Sub-Committee and Board.

The Gallery operates due diligence in the preservation and management of its artwork assets — ensuring works are displayed in such a way as to minimize risk of accidental damage. The Gallery monitors climate conditions and adequate storage measures are strictly adhered to, in addition CCTV recording is fully operational ensuring all works are secured against theft and security.
